

About the Statement of Authorship and Copyright Transfer Form

An Authorship Form signed by all authors covers authorship responsibility, copyright transfer, Institutional Review Board/Animal Care Committee Approval, financial disclosure, and publication charge agreement for manuscripts submitted to *Biology of Reproduction* (BOR).

After a manuscript has been submitted to BOR, the [Bench>Press submission system](#) generates a Statement of Authorship and Copyright Transfer Form for that manuscript. Authors may view and print this document by logging into the submission site (<http://submit.biolreprod.org>), entering the Author Area, locating the manuscript (typically in "Under Review – Check Status"), and clicking the "Authorship Form" link.
